Reservation System Registration

- Reservations for our tennis court are managed through ReserveMyCourt (RMC)
 (www.reservemycourt.com or the app RMC2020)
- After creating your account on ReserveMyCourt, please set your address in 'My Profile' and add club Southern Woods – Brentwood (select My Clubs → Connect to My Club → Southern Woods – Brentwood)
- The account administrator will verify HOA residency through account information (name/address).
- Non-HOA members living in Southern Woods who have purchased a membership (pool keycard) are eligible to use the tennis court and its reservation system.

Reservation Rules

- 1. Tennis clinics, camps, or group instructions by paid or unpaid instructors are strictly prohibited.
- 2. A tennis lesson provided by an instructor will be allowed once per week per resident. The same instructor will only be allowed on the court for a period of 3 hours (maximum) per day. If the same instructor is found to be on the court more than 3 hours per day, the individual who reserved the time slot shall have their Reserve My Court (RMC) privileges suspended for 30 days.
- 3. No-show policy: If you reserve a court and can not make it, cancel your reservation. The cancellation should occur a minimum of 24 hours in advance of your reservation. Upon any resident's first no-show, a gentle email reminder will be sent out. Upon a total of three no-shows within any calendar year, the resident will lose their RMC privilege for 30 days.
- 4. Only Southern Woods West HOA members are allowed to reserve court time.
- 5. The Tennis Committee reserves the right to amend these rules, cancel reservations or suspend reservation privileges based upon any activity it determines goes against intended fair court access to all HOA residents.
- 6. A maximum of two reservations per week per address will be allowed.

Tennis Court Rules

- 1. The court is for Southern Woods West HOA residents and guests only.
- 2. One-hour time limit when people are waiting to use the court. The exception to this is that if the court has been reserved for 90 minutes, the full 90-minute time period of the reservation takes priority.
- 3. No food, smoking, glass, or alcoholic beverages.
- 4. No pets.
- 5. No bicycles, rollerblades, skateboards, motorized toys, etc.
- 6. Tennis shoes are only to be worn on the court.
- 7. Children under the age of 12 must be accompanied by an adult.
- 8. Net shall not be lowered, raised, or abused as well as any other equipment or fence/gate.
- 9. Remove any trash or debris (water bottles, tennis cans, covers, etc.) off the court and offsite. Take home. Do not discard in trash bins at the end of the drive.
- 10. Use court at your own risk.
- 11. Tennis camps, clinics, and group instructions by paid or unpaid instructors are strictly prohibited.
- 12. A tennis lesson provided by an instructor will be allowed once per week per resident. The same instructor will only be allowed on the court for a period of 3 hours per day.
- 13. Court hours are 8:00 AM-8:00 PM or sunset, whichever occurs earlier.
- 14. Reservations take priority over walk-ons.
- 15. All violations are subject to HOA fines. Court reservation privileges (RMC) may be suspended for any rule violation.
